Financials:

We are at 83.29% of the fiscal year

PH Revenue is at 83.61%, PH Expenditures at 80.13% Discussion regarding Medicaid reimbursements. Medicaid is reimbursing PH for services provided. This is not the situation in other Medicaid programs. Keep watchful eye.

EH Revenue is at 80%, EH Expenditures at 72.39%; expected to be lower because of program manager position opening.

Dorn provided an update of the First Five Grant results. 1st Five was awarded to American Home Finding in the new Collaborative Service Area 15. MCPHD appealed. It sounds like there were several appeals across the state. It was noted that the scoring tool that was provided to the applicants was not the same tool used in scoring. MCPHD was provided an appeal date of June 10, 2022. Since then, MCPHD received an email that the 1st Five Application has been rescinded. Dorn requested it in writing confirmation that the appeal date is cancelled. The IDPH declined to confirm that, stating the appeal would be cancelled if requested by the appellant. Dorn stated she will plan to attend, because this entire cycle has been unpredictable. Dorn reported that just before this meeting, an email was received from IDPH telling us to expect that the current 1st Five contract would be extended through December 2022, and more information would be forthcoming. It was noted that all emails regarding 1st Five have come from program staff, not leadership of the bureau, noting the Bureau Chief has not been the person sending the communications.

Dorn provided an update of the WIC Applications. Notice of Awards were supposed to come on May 20, 2022. It was posted on the Notice of Award web page that the notice of Award has been pushed back to mid-June, without further explanation.

Berdette Davis left the meeting.

The Board of Health did Kim Dorn's performance Evaluation.
